EXHIBITOR'S INDEMNITY AGREEMENT

It is hereby agreed by and between the National Supermarket Association ("NSA") and the undersigned Exhibitor ("Exhibitor") that, as and for consideration for Exhibitor being permitted to exhibit at, market at, and/or participate in the National Supermarket Association Trade Show ("Event") on August 30, 2017 at Resorts World Casino New York City, in addition to and without effect on any other consideration by and between the NSA and Exhibitor as may be described herein or in any other document:

1. Insurance: Exhibitor shall maintain, with financially sound and reputable insurer(s), licensed in the State of New York with a rating of no less than A: X according to A.M. Best, the following insurance coverage(s): **(a)** comprehensive or commercial general liability policy including contractual liability, products, completed operations and broad form property damage coverage affording protection on an occurrence basis for claims arising out of bodily injury, death, and property damage and having limits of not less than \$2 million per occurrence and in the general aggregate; **(b)** Worker's Compensation coverage in compliance with the Worker's Compensation law of the State of New York; and **(c)** for any motor vehicle to be used during the Event or on the premises where the Event is held, automobile liability insurance in compliance with the laws of the State of New York with a per occurrence limit of \$500,000 and a general aggregate limit of at least \$1 million.

With respect to the general liability coverage detailed in (a) above, coverage shall not be excluded for employees of the named insured and the following entities shall be named as additional insureds:

- National Supermarket Association, Inc.
- Resorts World Casino New York City
- Genting New York L.L.C.
- The State of New York,
- New York Racing Association

And any owners, partners, affiliates, members, shareholders, officers, directors, employees, representatives, agents, contractors, consultants, licensees, successors, assigns, trustees, officials and servants of any of the foregoing.

2. Indemnification/Hold Harmless: Exhibitor shall, to the fullest extent permitted by law, at its own cost and expense, defend, indemnify and hold harmless the National Supermarket Association, Inc., Resorts World Casino New York City, the State of New York, New York Racing Association, and any owners, partners, affiliates, members, shareholders, officers, directors, employees, representatives, agents, contractors, consultants, licensees, successors, assigns, trustees, officials and servants of any of the foregoing from and against any and all claims, losses, damages, liabilities and expenses (including attorneys fees and statutory liability) resulting from injury and/or death or damage to or loss of property arising out of any negligent or wrongful act, error or omission of Exhibitor, its employees, agents or contractors.

3. Term: This agreement shall remain in force during the Event as well as during load-in and set-up prior to the Event and breakdown and load-out thereafter as well as at any time that Exhibitor is on the Resorts World Casino New York City property or complex in conjunction with the Event. In addition, the indemnity and insurance provisions herein shall survive the conclusion of the Event for the purposes of claims made as a result of incidents occurring during or around the time of the Event.

4. Compliance: All Certificates of Insurance required herein shall be provided to the NSA at its address 30-50 Whitestone Expressway, Suite 301, Flushing, New York 11354 (Fax: 718-747-2859) at least thirty (30) days prior to the Event.
